

General information	<p>NORDIC IMMUNOLOGY offers over 1700 basic immunological reagents including antisera, antibodies, immunoconjugates, purified proteins, controls and calibrators. In over 30 years, NORDIC has established working reference standards which are periodically reviewed in the light of current progress.</p> <p>NORDENZYME™ is the name of a group of polyclonal immunologic reagents to enzymes. Two different types of rabbit or sheep anti-enzyme products are offered: the isolated IgG fractions (7S) of the specific antisera and the isolated antibodies (PAb) to the enzymes. Products against some 180 enzymes are available either as 7S or PAb or in both forms. The 7S fractions are also available in biotinylated form.</p> <p>The NORDENZYME™ products have been obtained by immunization with highly purified enzymes.</p>	
Description	Affinity purified antibodies of polyclonal rabbit antiserum to thermolysin from <i>Bacillus thermoproteolyticus</i> rokko

Biological origin	Rabbit	
Physical form	Purified hyperimmune rabbit IgG antibodies lyophilised from a solution in phosphate buffered saline (PBS, pH 7.2), stabilized with dextran.	
Preservative	No preservative added, as it may interfere with the antibody activity. No foreign protein added.	
Immunogen	Thermolysin isolated and purified from <i>Bacillus thermoproteolyticus</i> rokko. Freund's complete adjuvant is used in the first step of the immunization procedure.	
Purification	Specific polyclonal antibody fractions were prepared by solid phase affinity chromatography.	
Identity & Specificity	The reagents were evaluated for potency, purity and specificity using most or all of the following techniques: immunoelectrophoresis, cross-immunoelectrophoresis, single radial immunodiffusion (Ouchterlony), block titration, ELISA, immunoblotting and enzyme inhibition.	
Cross-reactivity	Cross-reactivities against enzymes of other sources may occur but have not been determined.	
Physicochemical characteristics	PAb concentration 1 mg/0.5ml. No foreign proteins added.	
Intended use	This product is intended for use in precipitating and non-precipitating antibody-binding assays (such as e.g., ELISA and Western blotting and immunofluorescence or histochemical techniques); to prepare an insoluble immuno-affinity adsorbent; for labelling with a marker of the customer's own choice.	
Directions for use	Working dilutions in non-precipitating antibody-binding techniques may vary widely, but may be between 1/10,000 and 1/100,000.	
Handling	The lyophilised PAb fraction is shipped at ambient temperature and may be stored at +4°C; prolonged storage at or below -20°C. It is reconstituted by adding 0.5 ml sterile distilled water, spun down to remove insoluble particles, divided into small aliquots, frozen and stored at or below -20°C. Prior to use, an aliquot is thawed slowly at ambient temperature, spun down again and used to prepare working dilutions by adding sterile phosphate buffered saline (PBS, pH 7.2). Repeated thawing and freezing should be avoided. Working dilutions should be stored at +4°C, not refrozen, and preferably used the same day. If a slight precipitation occurs upon storage, this should be removed by centrifugation. It will not affect the performance of the product.	
Packing	Vial with 1 mg PAb fraction, lyophilised from 0.5 ml phosphate buffered saline.	
Storage / shelf life	Lyophilised at +4°C	at least 10 years
	reconstituted at or below -20°C	3-5 years
	reconstituted at +4°C	7 days
